## Michigan Mineralogical Society's EXHIBITOR ADVISORY

**Date & Location:** The Greater Detroit Gem, Mineral & Fossil Show will be held at the Macomb Community College Expo Center, Building P, 14500 E. 12 Mile Rd., Warren, MI 48088. The show is open to the public on Friday from 9 am to 6 pm, Saturday from 10 am to 7 pm and Sunday from 11 am to 5 pm. Please refer to the Display Application for the specific dates of the show.

**Case Size:** MMS Pony Case (Display Case) inside dimension is 46-1/2" wide X 22" high X 21" deep at the bottom and 22-1/2" at the top (dimensions vary slightly).

**Registrations and Badges:** Display location and exhibitor badges can be obtained at the MMS registration booth in front of the hall. The exhibitor's badge authorizes FREE admission to the show. There will be two (2) badges allotted per exhibitor regardless of total size, number of cases or number of contributors to the exhibit.

**Installing and Removing Displays:** Set-up will be on Thursday between noon and 9 pm. Each exhibitor is to remove the exhibit immediately after the close of the show on Sunday. However, no exhibit may be dismantled or removed before 5 pm Sunday without the knowledge and consent of the Show Chairperson. No Exhibitor may open their case during the show without the consent of the Display Chairperson.

**Restrictions:** No exhibitor shall assign, sublet or share any part of or all their allocated space without the knowledge and consent of the Display Chair. The Show Committee reserves the right to restrict any exhibit for any reason and prohibit any exhibit which, in its sole opinion, may detract from the general character of the Show. This restriction includes persons, printed matter, objects or anything that detracts from the general character of the show. Canvassing and distribution of advertising materials in any part of the show is strictly forbidden without the consent of the Show Chairperson. No exhibitor may place advertising matter in or on their display case. Violation of the above is not cause for any refund or reimbursements.

**Security:** There will be round the clock security and all reasonable and expected precautions.

**Liability:** It is hereby agreed that the Michigan Mineralogical Society, its officers, members or authorized agents shall not be liable for the loss, damage or destruction of any exhibit; or personal property of or injury to any exhibitor. Submission of a signed application constitutes acceptance of all rules and regulations outlined above.
